It is recognized by the GKV Spitzenverband (National Association of Statutory Health Insurance Funds), the German Association of Statutory Health Insurance Physicians as well as by the relevant German federal associations of the service providers.

## Why “Quality in Health Prevention“?

Despite of a common market place there are considerable international differences in the area of health prevention. This also concerns the legally required quality standards (e.g. security, hygiene and infrastructure).

In order to oppose a distortion of competition, in 2006, the European Spas Association (ESPA) co-founded the international quality certification “**EuropeSpa med**”. It addresses national and international health service providers (e.g. clinics, hotels).

The issuing authority is the EuropeSpa med & wellness GmbH, Wiesbaden, Germany.

“**Quality in Health Prevention**” is now the first international cross-sector interest group with the aim of improving the quality of national and international prevention measures.

Main tasks:

1. The further development of the “EuropeSpa med” quality criteria.
2. The organisation of specialist events, e.g. the future annual “European Quality Day on Health Prevention”.
